### HISTORY

Mast. MuneY, 4 years, old male, patient was admitted in this hospital with A/H/O - Burn injury from crackers at home time of burn - 8PM Date of burn - 28.10.19, Place of burn- cull mumore.

### ON EXAMINATION

GC - Sick, No Pallor, No Icterus, No cyanosis, No clubbing, No oedema.

Pulse - 80/Min BP - 120/74 mmHg R/S - B/L AE+ Temp - 98°F.

CVS - NAD CNS- NAD PA - Soft, Bs+. R/R - 20/Min.

SPO2 - 98% GCS - 15/15 WT- 20kg.

### INVESTIGATION

All the Investigation Reports are attached with Discharge Summary.

### COURSE IN HOSPITAL

Patient admitted in hospital through casualty on 02.11.19 under Dr. A.K Verma with above mentioned complaints. After Initial evaluation as per standardised protocol treatment initiated with IV antibiotics, IV Analgesic, Dressing Burn site and other supportive treatment given. All relevant investigations were sent + USG whole abdomen + Venous doppler both Lower Limb was done. Patient managed conservatively. Patient gradually responded to the given treatment condition of patient has improved. Now patient condition is stable and is being discharged with following advice and oral medicines.
