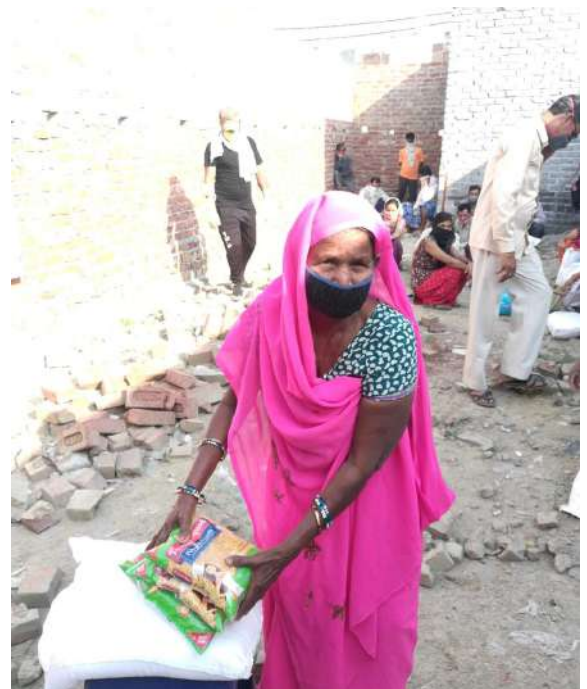

HISTORY

Mast. Lucky Kumar, 9month, old male, patient was admitted in this hospital with A/H/O accidental burn injury with hot water at home @12:30PM on 26.03.2020.

ON EXAMINATION

GC - Sick, Breathing spontaneous, Afebrile.

Pulse - 122/Min R/S - B/L AEE+ Temp - 98.2°F.

CVS - S1S2+ CNS- NAD PA - Soft, Bs+. R/R - 32/Min.

SPO2 - 98% GCS - 15/15

INVESTIGATION

All the Investigation Reports are attached with Discharge Summary.

COURSE IN HOSPITAL

Patient admitted in hospital through casualty on 26.03.2020 under Dr. A.K. Verma with above mentioned complaints. After Initial evaluation as per standardised protocol treatment initiated with IV fluids, IV antibiotics, IV PPI, IV Antiemetics, Antipyretic, Analgesic, Dressing and other supportive treatment also given. All necessary investigations were done. Patient gradually responded well to given treatment, condition of patient has improved. Today patient is being discharged with following advice and medication.

Syp. Levocetirizine	-2.5ml	-Twice a day x 5days
